

Terms and Conditions – Squire Hotels Win a Wedding campaign

1. CAMPAIGN

- 1.1 The Win a Wedding campaign is open to everyone above the age of 18. From now on, for the purposes of the terms and conditions, people that enter the competition will be known as and referred to as the 'Entrant/s'.
- 1.2 In order to participate in the campaign, entrants must be permanent residents in the United Kingdom.
- 1.3 The Win a Wedding campaign is organised by Squire Hotels and is to be run in conjunction with Wedding Ideas magazine.
- 1.4 The campaign is open to new entrants only. Entrants who submit an entry to the campaign with a wedding already booked at one of the participating hotels will be disqualified. An entrant who cancels a wedding already booked at one of the three hotels in the hope of winning would be disqualified from entering.
- 1.5 Each entrant may only submit one entry throughout the entirety of the campaign.
- 1.6 The competition can only be entered via Wedding Ideas magazine and/or the Wedding Ideas website which is www.weddingideasmag.com.
- 1.7 The campaign will only have one winner throughout its duration.
- 1.8 The winning entry, which from now on, for purposes of the terms and conditions, will be known as and referred to as the 'Winner', shall be selected by Wedding Ideas representatives and the winning 'Entrant' shall be notified by telephone and / or email on October 30th 2017. The terms and conditions for the entry mechanics of the competition will be that of the standard terms and conditions set out by Wedding Ideas as standard with all its competitions. - 1.9 Employees of Wedding Ideas, Squire Hotels Limited and KRPR (PR Company to Squire Hotels) are excluded from entering the competition.
- 1.10 The prize package offered with this campaign is non-negotiable and not redeemable for cash equivalent. Each supplier also has their own terms and conditions for the prize they are offering. See section 2.0 below for details of each.

2.0 SUPPLIERS

- 2.1 The wedding dress will be supplied by Natalie Ann Brides, Liverpool. The dress is a Mori Lee Designer dress, number 5108, and retails at £695. The winner is able to purchase, at an extra cost set by the management team of Natalie Ann Brides, a bridal belt or accessories to go with the dress. The dress is ordered on a six week Rush Cut in Ivory. Should the winner require white, it will take up to 16 weeks for delivery. The dress is only available in UK sizes 4 – 32. Squire Hotels, KRPR, Wedding Ideas magazine or Natalie Ann Brides cannot be held accountable for a delay in delivery. The decision on the terms and conditions set for the dress is final and the dress is non-transferable with no cash equivalent. Dress alterations and

optional extras will come at an extra cost to the winner. The prize excludes all other offers that Natalie Ann Brides is running.

- 2.2 The wedding cake will be supplied by Adorable Cakes, Chorley. The cake will be a round, three tier sponge wedding cake (measuring 10", 8" & 6") to the value of £250 or a cupcake tower to the same value. The value, £250, includes delivery and set up. Should the winner require extras exceeding the value, this is possible however the winner must make up the difference in price. Cake toppers and fresh flowers are not included and would need to be provided by the winner. The decision on the terms and conditions set for the cake is final and the cake is non-transferable with no cash equivalent. The prize excludes all other offers that Adorable Cakes is running.
- 2.3 The wedding photography will be supplied by Scrumptious Photography, Clitheroe, and will include photography services from the wedding ceremony to the speeches during the wedding breakfast and will include all digital images on a CD free from copyright. Optional extras such as photography of bride's hair and makeup, first dance and a professional wedding album can be purchased at a price set by Scrumptious Photography. The decision on the terms and conditions set for the photography is final and the package is non-transferable with no cash equivalent. The prize excludes all other offers that Scrumptious Photography is running.
- 2.4 The wedding suits will be supplied by Slaters Menswear, Manchester. Slaters will provide five complete hire wear outfits in either Morning, Evening or Highland wear. The prize includes shirt, tie, handkerchief, shoes, cufflinks and accidental damage waiver. The prize excludes all other offers that Slaters Menswear is running. The prize winner is responsible for all garments. The prize winner must return all the garments on the date agreed with Slaters Menswear at collection, failure to do so will result in late charges. The prize is not transferable to a third party; the winner is the person whose details appear on the entry form. The prize is not transferable to the cash equivalent. All five outfits must be used on the same function date.
- 2.5 The wedding confetti will be provided by Dollz Confetti, Preston. The prize is a Confetti Bar setup for the wedding including confetti for up to 60 guests in the preferred colour scheme. Delivery and set up is included. The prize excludes 'Fetti Pops' product. The decision on the terms and conditions set for the confetti is final and the package is non-transferable with no cash equivalent. The prize excludes all other offers that Dollz Confetti is running.
- 2.6 The wedding backdrop will be provided by Dollz Events, Preston. The prize is a 2.7m x 2.4m handmade, ivory, flower wall backdrop consisting of over 20 varieties of silk flowers. The backdrop is used as either a high table backdrop or a photo wall. A unique rustic 4ft LOVE letters accessorised with flowers is also part of the prize. Delivery and set up is included. Any damages to the props will be charged at cost price to the winner and no negotiation will be entered into on this matter. The decision on the terms and conditions set for the props listed is final and the package is non-transferable with no cash equivalent. The prize excludes all other offers that Dollz Events is running.

- 2.7 The makeup will be provided by Dollz Makeup and Hair, Preston. The prize is applicable to the winner and three bridesmaids. The prize is either a blow dry or hair up. Any hair accessories to be used must be provided by the winner. The makeup includes airbrush foundation and eyelashes only. The decision on the terms and conditions set for the hair and makeup is final and the package is non-transferable with no cash equivalent. The prize excludes all other offers that Dollz Makeup and Hair is running.
- 2.8 The wedding flowers will be provided by Verdure Floral Design, Manchester. The prize is a £500 voucher towards weddings flowers, centrepieces, travel and set up. Should the winner require more flowers, over the value of the voucher, £500, will be deducted from the total amount payable at the end. The decision on the terms and conditions set for the flowers is final. The prize excludes all other offers that Verdure Floral Design is running.
- 2.9 To confirm all prizes cannot be transferred to a third party and will only be awarded to the winner. No cash value is applicable to any of the prizes.

3.0 WEDDING

- 3.1 The wedding is to take place at one of the hotels within the Squire Hotels group of either Best Western Plus Sablesbury Hotel, Preston, The Hydro hotel, Windermere, or Etrop Grange, Manchester Airport.
- 3.2 The wedding is to take place on either Saturday, May 12th 2018 or Saturday, September 22nd 2018.
- 3.3 The winner must choose the date of the wedding by 30th November 2017 and inform Squire Hotels' PR company, KRPR. Should the winner fail to meet the deadline, the prize will be forfeited and Wedding Ideas will be commissioned to conduct a redraw.
- 3.4 Squire Hotels is to provide at the chosen venue the following: venue hire, wedding co-ordinator, red carpet arrival, arrival/post ceremony drink, white linen and napkins, wedding ceremony for 40 guests, wedding breakfast room and a three course meal for 40 guests, sparkling wine for the toast, white chair covers and sash, master of ceremonies, cake stand and knife, evening room hire, complimentary menu tasting for the winner, evening buffet for 80 guests, DJ/Evening entertainment, honeymoon suite for bride and groom on the night of the wedding and a complimentary first anniversary stay for the winners inclusive of dinner and English breakfast. The decision on the terms and conditions set for the venue is final and the room dressing is non-transferable with no cash equivalent. Optional extras, such as an increase in numbers, will come at an extra cost to the winner. The prize excludes all other offers that Squire Hotels and hotels within its group are running. The prize excludes the minister for the wedding service itself. It is the winners full responsibility to make the necessary legal arrangements for the service, including the minister. It is the winners full responsibility to ensure all legal paperwork is completed in order to qualify the marriage as being legal. Failure to do so is not the responsibility of Squire Hotels or KRPR.
- 3.5 Only one wedding date is to be chosen. Once the date is chosen that is confirmed and it cannot be changed.

- 3.6 Only one venue is to be chosen. Once the venue is chosen that is confirmed and it cannot be changed.
- 3.7 Transport to the wedding venue on the chosen wedding date, or to any supplier meetings needed prior to the wedding date, are in no way included in the prize.
- 3.8 Additional hotel bedrooms for wedding guests are not included. These can be booked but will come at an extra cost and are subject to availability.
- 3.8 To confirm, the prize, and all its elements, are non-transferable and a cash equivalent is not available.
